## **PLEASE NOTE BEFORE YOU SUBMIT**

- Read ALL the information on the call for courses page of the RANZCO Congress website
- All submissions must be made via the online portal in X-CD
- Have all your submission information on hand (refer to the course submission questions from page 2 of this document)
- Ensure ALL presenters are aware of and agree with the submission details and terms and conditions.
- Submitting authors can edit the submission up until the call for courses closes (Thursday 10th April @midnight AEST)

## **A. Register as a user in the online submission system**

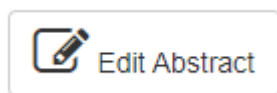
